Delegate registration fee

Speakers and ENA members running NIA/NIC projects are entitled to attend the conference free of charge and must register online prior to the event by visiting the LCNI registration site www.cvent.com/d/7yq9sf.

Charities and academic organisations and ENA affiliates and associations are entitled to a 25% discount on all delegate passes. Once this type of pass has been selected the registration team will need to check that the relevant organisation is eligible for the discount and may request evidence of their business status. An email will then be sent to approve or decline their request for a discounted rate.

This approval process also applies to Students, Speakers and Press to confirm their access to the event.

Refunds

Cancellation charges for registration fees are as follows:

- If cancelled by 29 August, 100% refund will be given.
- If cancelled by 29 September, 50% refund will be given.
- Post 29 September, there will be no refunds.
